RESOLUTION #R-2003-33

HONORARY RESOLUTION RECOGNIZING WAGNER COMPANIES FOR 150 YEARS OF SERVICE

WHEREAS, in 1853, Wilhelm Wagner, the founding Editor of the Deutscher Anzeiger (German Crier), established the Wagner Companies which will celebrate 150 years of service in the City of Freeport; and

WHEREAS, the Wagner Companies have the honor of being the oldest family owned and operated printing company in the United States, the oldest family owned and operated business in the City of Chicago, and, the third oldest family firm in the State of Illinois; and

RESOLUTION INCREASING CABLE FRANCHISE FEE TO 5%

This resolution was laid over from the meeting of April 7, 2003, when it was moved by Alderman Gaulrapp, seconded by Alderman Rinehart for approval. Alderman Gaulrapp moved, seconded by Alderwoman Bender that this resolution be laid over in order for the new council to consider. The motion carried.

Mayor Gitz then outlined some of the items the outgoing council members accomplished. He also welcomed the new council members.

INSTALLATION OF NEW COUNCIL MEMBERS

City Clerk, Latacia Ishmon, swore in George Gaulrapp, Nickee Bender, Robert Varner, Mike Clark, James Dawson, Shawn Boldt, Linda O'Neill, and Dean Wright as the newly elected aldermen for the City of Freeport. The aldermen then took their seats.

ROLL CALL

Present were Aldermen Gaulrapp, Bender, Varner, Clark, Dawson, Boldt, O"Neill, and Wright.

1st READING

ORDINANCE #2003-36

AN ORDINANCE REPEALING AND REPLACING SECTION 220.11 (COUNCIL COMMITTEES) OF CHAPTER 220 (COUNCIL) AND AMENDING SECTION 222.02 ENTITLED (COMMITTEE APPROVAL) OF CHAPTER 222 (ORDINANCES AND RESOLUTIONS) OF THE CODIFIED ORDINANCES OF THE CITY OF FREEPORT, ILLINOIS

Alderwoman Bender, Executive Committee Chair, stated that the committee held a meeting on April 18, 2003. The committee discussed Ordinance #2002-75, which covers the committee structure. After much discussion of the pros and cons to a four-member committee, the committee voted unanimously to change the current ordinance to four standing committees with four-aldermen on each committee plus the executive committee. It also stated that if a tie vote should occur in the committee then the item at hand would come to the entire council with no recommendation and the council, as whole, would then take action on the item.

Alderman Gaulrapp brought up his concerns with the four-member committee structure as to when two persons from a committee would get together and the issue of violating the Open Meetings Act. Alderman Boldt stated that he believed the four-person committee would involve the aldermen more than currently, with Alderman Dawson in agreement. With this change all alderpersons are either a chair or a vice-chair, providing them more of an opportunity to be involved.

Mayor Jim Gitz brought up the current Ordinance #2002-75, page two, paragraph beginning with "The Chairperson of the Executive Committee shall..." in reference to the "most senior" member of the council, with much discussion following. Mayor Gitz wanted it clear so some future Executive Committee would not be faced with how to interoperate these changes. This ordinance was originally established with the Executive Committee consisting of the chairpersons from each standing committee and to include the most senior alderman and who is not already a member of the Executive Committee. With the new four-member committee structure, the Executive Committee will consist of the chairperson from each committee and the most senior alderperson. If the most senior alderperson were also a committee chair the next most senior alderperson would be added to the Executive Committee. A motion was made by Alderman Gaulrapp and seconded by Alderman Boldt to have Sarah Griffin, Corporation Counsel, make the changes as recommended, i.e. standing committees now would consist of four members not five and was to include the wording that "the term" would be consecutive years fulfilled by an alderperson, as well as how the committee handles if the senior alderperson also being a chairperson.

The discussion was then opened up regarding the make-up of those on the newly formed committees. The committee structure was accepted as presented.

Alderwoman Bender moved, seconded by Alderman Dawson for approval of this ordinance. Alderwoman Bender moved, seconded by Alderman Gaulrapp to suspend the rules in order to consider this ordinance at this meeting. On the roll call of yeas and nays to suspend the rules, Aldermen Gaulrapp, Bender, Varner, Clark, Dawson, Boldt, O'Neill, and Wright voted yea. The motion carried. On the roll call of yeas and nays to approve the ordinance, Aldermen Gaulrapp, Bender, Varner, Clark, Dawson, Boldt, O'Neill, and Wright voted yea. The ordinance was approved.
