The reports discussed our portfolio and the following topics: Economic environment, GDP, unemployment, fed. fund rate, fixed income market, U.S. equity market, International equity market, and manager performance. Mike also discussed the status of Harbor International, William Blair International, and Franklin International as all remaining on Alert due to performance. Portfolio return: Qtr. 3.3%, YTD 10.3%, 1 YR. 10.6%, 2 YR. 9.5%, 3 YR. 6.0%, 4 YR. 6.2%, 5 YR. 7 .5%. Mike also discussed that the fund is at an all time high of \$34.8 Mil and that we pay out \$1.5 Mil a year.
