Alderwoman Steele, Chair, stated that the committee held a special meeting on August 5, 2002. Demolition bids were presented to the committee from Alber and Brokhausen. They were as follows:

The bids were "cherry picked for the lowest bid. The committee voted unanimously to award Alber three demolitions totaling \$6,669 and Brokhausen four demolitions totaling \$6,441.00; for a total of \$13,110 and Alderwoman Steele so moved, seconded by Alderman Dawson. On the roll call of yeas and nays, Aldermen Jenkins, Gaulrapp, Rinehart, Bender, Steele, Bush, Moore-Howard, Goley, Veer, Boldt, Urban, and Dawson voted yea. The bids were accepted.

Alderwoman Steele also stated that the committee voted unanimously to increase hangar rent at the airport by \$10. This would increase the rent collected by \$6,000. She stated that the next meeting would be August 15, 2002, in City Council Chambers.

#### **NEW BUSINESS**

Alderman Jenkins stated that he received a letter from a concerned citizen with a phony name. He stated that he appreciates it when citizens have serious concerns, but he requested that they sign their real name. He stated that the Street Department has been doing an outstanding job paving the streets. He said that he has never seen this many streets done in one year.

Alderman Gaulrapp welcomed Reggie Taylor and the new police chief to the City Hall. He also stated that he would like to see the order of the agenda in the New Business section changed. He will discuss this with the appropriate committee.

Alderman Rinehart wished Police Chief Kentner well in his retirement and stated that he looks forward to working with the new chief. He also thanked the sponsors of Cruise Night.

Alderwoman Bender thanked Police Chief Kentner for his years of service and welcomed Reggie Taylor and Jerry Whitmore. She also announced that there would be a fundraiser for Cameron Davis on September 7, 2002, from 1:00pm to 7:00pm, at the Farm Bureau.

Alderwoman Steele thanked Police Chief Kentner for all his efforts and the programs that he started. She stated that the Civilian Academy is a wonderful program and that he would be greatly missed. She stated that she looks forward to working with the new chief, Jerry Whitmore. She stated that received information from two Gulf War Veterans, who are receiving medical and monthly benefits. She stated that the new legislation is working and she thanked everyone that supported Congressman Manzullo. She stated that there would be a fundraiser for the All Veteran's Memorial Park. Tickets for the

drawing will be sold at the Stephenson County Fair and the drawing will be on November 11, 2002. She also welcomed Reggie Taylor.

Alderman Bush welcomed the new police chief. He announced that there would be a Back to School Celebration on August 17, 2002. He stated that the Freeport Health Network would be kicking off the event with a healthy 1K walk.

Alderman Moore-Howard wished Police Chief Kentner good luck and encouraged the new chief. She also congratulated Fire Chief Blackbourn on the funding the Fire Department received.

Alderman Goley welcomed Reggie and Jerry Whitmore. He also wished Police Chief Kentner well.

Alderwoman Veer welcomed Reggie and Jerry Whitmore. She also wished Police Chief Kenter good luck. She stated that she felt Cruise Night was a great success.

Alderman Boldt challenged the mystery writer to quit hiding behind a false name.

Alderman Urban wished Police Kentner the best of luck during his retirement. He also welcomed Reggie Taylor and Jerry Whitmore.

Alderman Dawson stated that as Public Safety Chair, it has been a pleasure working with Police Chief Kentner. He welcomed Reggie Taylor and Jerry Whitmore to the city. He stated that he enjoyed attending Cruise Night; it was a well, put together event.

Fire Chief, Jim Blackbourn, welcomed Reggie Taylor. He wished Chief Kentner well and stated that he looks forward to working with the new Police Chief Jerry Whitmore. He also stated that there was a press conference at Fire Station #1 with Congressman Manzullo. The Fire Department was awarded a \$58,000 grant. The money will be used to purchase new airpacks, replacing the old airpacks, which are 15 years old.

The new chief was appointed in order to allow a smooth transitioning process.
