QUORUM

At 7:00pm, a quorum being present, Mayor Gitz called the meeting to order.

RECORD

Present were Aldermen Bender, Varner, Clark, Boldt, O'Neill, Wright, and Gaulrapp.

PLEDGE OF ALLEGIANCE

At this time, the Pledge of Allegiance was led by Alderwoman Bender.

APPROVAL OF THE AGENDA

Alderwoman Bender moved, seconded by Alderman Varner for approval of the agenda. The motion carried.

PUBLIC HEARINGS

There was a public hearing on the Inducement/Reimbursement Resolution of the City of Freeport, Illinois in connection with Industrial Development Revenue Bonds for a Senior Housing Project.

Economic Development Director, Bob Skurla and Blair Minton from Minton & Associates explained the process and answered all questions. There being no additional comments, Alderwoman Bender moved, seconded by Alderman Gaulrapp to close the public hearing. The motion carried.

Alderman Clark moved, seconded by Alderman Wright to accept these appointments. The motion carried.

COMMITTEE REPORTS

PUBLIC WORKS

Alderman Boldt, Chair, stated that the committee held a meeting on November 15, 2004. The committee received one bid from Freeport Sheet Metal in the amount of \$1,500 for the removal of the City Light's air conditioner. The air conditioner needs to be removed for safety reasons. The committee voted unanimously to accept this bid and Alderman Boldt so moved, seconded by Alderman Clark. On the roll call of yeas and nays, Alderman Bender, Varner, Clark, Boldt, O'Neill, Wright, and Gaulrapp voted yea. The motion carried.

Alderman Boldt announced that on November 19, 2004, at 6:00pm, in City Council Chambers, there would be an informational session regarding the cell tower located on Burchard Avenue.

FINANCE

Fire Chief, Jim Blackbourn, stated that the Fire Department would be hosting a two-day training session on November 15 &16, 2004 on the use and care of respirators. This training session is funded by the Illinois Terrorism Task Force.

City Accountant, Duane Price, reported that the payment for the 5-yard and 10-yard dump trucks would be made prior to the next council meeting.
