## COMMITTEE OF THE WHOLE REPORT SPECIAL MEETING Monday, June 1, 2015

#### 1. CALL TO ORDER

# 5. <u>PRESENTATION OF THE 2015-2016 CITY BUDGET - POLICE AND FIRE DEPARTMENTS</u>

Finance Director Haggard stated that she provided to the council the 2015-2016 City of Freeport Budget at the Committee of the Whole meeting held on May 11, 2015 and this is a working preliminary document. She stated the purpose of tonight's discussion will be the two departments having to do with Public Safety including Police and Fire Department. Director Haggard stated on the agenda for this meeting were updated budget documents and this afternoon she met with the chiefs for Fire and Police and have placed copies of their budgets on the desks of the council so they have the most up-to-date figures.
