RESOLUTION TO REAUTHORIZE PUBLIC SIDEWALK PROGRAM

WHEREAS, Freeport has more than 50 miles of publicly used sidewalks in a state of disrepair and disintegration; and

WHEREAS, previous programs to remove disintegrated sidewalks by the Street Department and others, have proved insufficient to address the deteriorated condition of sidewalks throughout older neighborhoods; and

WHEREAS, in several previous years the City Council has adopted several resolutions to continue and reauthorize a Public Sidewalk Program; and

WHEREAS, the Mayor and the City Council have determined that it is in the best interests of the health, safety and welfare of Freeport to continue this program; and

WHEREAS, there are ever-growing numbers of pedestrians who frequently use sidewalks and who are endangered by sidewalks in a condition of disrepair.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, ILLINOIS that it does hereby approve Exhibit A to this Resolution, and further hereby authorizes the Mayor, the City Clerk and other City officials and employees, as may be necessary, to execute the provisions of this Resolution and create any other documents that prove necessary to implement the attached Exhibit A and this Resolution.

<u>Section 1</u>: That the Preliminary Plat for Countryside Estates Subdivision, a copy of which is attached hereto and made part hereof and marked as "Exhibit A", is hereby amended to convert Lots 91-96 to Lot 116.

<u>Section 2</u>: That this approval is tentative only, involving merely the general acceptability of the layout as submitted, and shall be valid for a maximum period of one (1) year, unless the developer applies for, and this City Council grants, an extension thereof.

Section 3: This Resolution shall be effective immediately upon its passage by the City Council and its approval by the Mayor.

WHEREAS, that Appropriation Ordinance was based upon an underlying budget document, which is shown in Attachment A; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, ILLINOIS that the document attached hereto and made a part hereof as Attachment A, is hereby adopted as the spending plan for the City of Freeport and shall be accorded such recognition in the spending of the City funds.

BE IT FURTHER RESOLVED that the spending of contingency funds is intended to have prior City Council approval, with the exception that the Finance Director or his or her designee shall have the authority to expend contingency funds in accordance with Attachment B, as long as the Finance Committee of the City Council is given a monthly report of such expenditures.

BE IT FURTHER RESOLVED that all resolutions or parts of resolutions in conflict with this Resolution are repealed insofar as they conflict.

BE IT FURTHER RESOLVED that this Resolution is passed under the Home Rule Authority of the City of Freeport as provided in Section 6 of Article VII of the Illinois Constitution of 1970.
