### RESOLUTION #R-2005-31

# RESOLUTION TO AMEND THE PRELIMINARY PLAT FOR COUNTRYSIDE ESTATES TO CONVERT LOTS 91-96 TO LOT 116

WHEREAS, Section 1224.03 of Chapter 1224 (Subdivision Regulations) of the Codified Ordinances of the City of Freeport and Section 205/2 of the Illinois Plat Act (765 ILCS 205/2) and Section 5/11-15-1 of the Illinois Municipal Code (65 ILCS 5/11-15/1) all authorize a city council to approve preliminary and final plats for all subdivisions located inside of the corporate boundaries of the city or within one-and-a-half miles outside of the corporate boundaries of the city; and

WHEREAS, at a meeting held on June 9, 2005, and subsequent to a public hearing, the Freeport Planning Commission by a majority vote recommended that this City Council amend the Preliminary Plat for Countryside Estates Subdivision, which is located within the city limits of the City of Freeport, Illinois, to convert Lots 91-96 to Lot 116.

### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, ILLINOIS as follows:

<u>Section 1</u>: That the Preliminary Plat for Countryside Estates Subdivision, a copy of which is attached hereto and made part hereof and marked as "Exhibit A", is hereby amended to convert Lots 91-96 to Lot 116.

**Section 2**: That this approval is tentative only, involving merely the general acceptability of the layout as submitted, and shall be valid for a maximum period of one (1) year, unless the developer applies for, and this City Council grants, an extension thereof.

<u>Section 3</u>: This Resolution shall be effective immediately upon its passage by the City Council and its approval by the Mayor.

<u>Section 4</u>: This Resolution is expressly adopted pursuant to the Home Rule authority of the City of Freeport under Section 6(a) of Article VII of the Illinois Constitution of 1970; and

<u>Section 5</u>: That all Resolutions or motions or parts of resolutions or motions in conflict with this Resolution are repealed insofar as they conflict.

**Section 6**: If any section, clause or provision of this Resolution be declared by a Court of competent jurisdiction to be invalid, such decision shall not affect the validity of the Resolution as a whole or any part thereof, other than the part so declared to be invalid, and this City Council expressly declares that it would have enacted this Resolution even with the invalid portion deleted.

### RESOLUTION #R-2005-32

### RESOLUTION TO APPROVE FINAL PLAT FOR COUNTRYSIDE ESTATES SUBDIVISION PLAT 14

WHEREAS, Section 5/11-15-1 of the Illinois Municipal Code (65 ILCS 5/11-15-1), authorizes a city to enact an ordinance mandating that the city council approve all plats of subdivisions to be located inside city's corporate boundaries or within a one-and-a-half mile area extending from said corporate boundaries provided that the city has also enacted a Subdivision ordinance; and

**WHEREAS**, the City of Freeport has enacted such a Subdivision Ordinance, known as Chapter 1224 of the Codified Ordinances of the City of Freeport; and

WHEREAS, Section 1224.05(d)(6) of Chapter 1224 of the Freeport Codified Ordinances provides that all Subdivision plats "shall be submitted to the City Council for approval and for

acceptance of all streets, alleys, ways, easements, parks or other areas preserved for, or dedicated to, the public, by resolution; and

**WHEREAS**, on January 18, 2005, this City Council approved the preliminary plat for Countryside Estates Subdivision, located within the city limits of the City of Freeport, Illinois; and

WHEREAS, the final plat for said Countryside Estates Subdivision Plat 14, a copy of which is attached hereto as "Exhibit A", and made a part hereof, substantially conforms to the preliminary plat as approved; and

**WHEREAS**, at a regular meeting held June 9, 2005, and subsequent to a public hearing, the Freeport Planning Commission unanimously recommended that the City Council approve the final plat for Countryside Estates Subdivision Plat 14.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, ILLINOIS that the Final Plat of Countryside Estates Subdivision Plat 14 as set forth in Exhibit A, is hereby approved.

**BE IT FURTHER RESOLVED** that the City Clerk is hereby directed to attach a copy of this Resolution to a copy of the plat, for the purpose of recording the plat by the subdivider with the County Recorder; and upon said recording of the plat, the subdivider shall file a certified, reproducible copy of the plat with the Community Development Office.

**BE IT FURTHER RESOLVED** that this Resolution is expressly adopted pursuant to the Home Rule Powers of the City of Freeport under Section 6 of Article VII of the Illinois Constitution of 1970; and all Resolutions or parts of motions in conflict with this Resolution are repealed insofar as they conflict.

### RESOLUTION #R-2005-38

### **RESOLUTION TO ADOPT COBRA RATES EFFECTIVE AUGUST 1, 2005**

WHEREAS, pursuant to Section 54.4980b-8 of the Consolidated Omnibus Budget Reconciliation act of 199 (COBRA), the City of Freeport is allowed to establish COBRA rates at a maximum of once every 12 months; and

WHEREAS, the Finance Committee concurs with the administrative staff recommendation to adopt single, single plus one and family COBRA rates for the City's healthcare continuation coverage for terminated employees effective August 1, 2005 which were determined through costs in an actuarially accepted manner as provided by the Northern Illinois Heath Plan and Boyd Consulting Group.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, ILLINOIS that the Mayor Is herby authorized to amend the adopted COBRA rates for continuing healthcare coverage for the new plan design within the regulations set forth in the COBRA regulation monthly premiums for single coverage of \$503.99, single plus one dependent coverage of \$918.49, family coverage of \$1,246.89, retirees' prescription single coverage of \$70.72, and retirees' family coverage of \$180.84, as recommended by Boyd Consulting Group.

**BE IT FURTHER RESOVED** that all resolutions of parts of resolutions in conflict with this Resolution are repealed insofar as they conflict.

**BE IT FURTHER RESOLVED** that this Resolution is passed under the home Rule Authority of the City of Freeport as provided in Section 6 of Article VII of the Illinois Constitution of 1970.

Alderman Boldt, Finance Chair, stated that the committee held a meeting on June 27, 2005. The committee voted unanimously to adopt this resolution and Alderwoman O'Neill so moved, seconded by Alderman Varner.
