1st READING ORDINANCE #2005-42

RESOLUTION #R-2005-44

RESOLUTION AUTHORIZING AGREEMENT FOR ENGINEERING SERVICES AND LAND ACQUISITION SERVICES FOR ALBERTUS AIRPORT GRANT FROM IDOT

WHEREAS, the City of Freeport, Albertus Airport, was selected as part of the State/Local Airport Improvement Program; and

WHEREAS, the Airport Participation Agreement with IDOT requires the City enter into a contract approved by IDOT or the FAA in connection with this Project, using a consulting engineer who is prequalified in accordance with IDOT procedures.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, ILLINOIS that the Mayor of the City of Freeport is hereby authorized and directed to sign, execute and seek IDOT approval on behalf of the City of Freeport, the attached

"Agreement for Architectural, Engineering, and Planning Services for Airports" with CRAWFORD, MURPHY & TILLY, INC.

BE IT FURTHER RESOLVED that this Resolution is expressly adopted pursuant to the Home Rule authority of the City of Freeport under Section 6(a) of Article VII of the Illinois constitution of 1970; and all Resolutions or motions in conflict with this Resolution are repealed insofar as they conflict.

There was leave granted to hear from Community Development Director, Shelly Griswold who gave a brief explanation of the grant. Alderman Varner moved, seconded by Alderman Boldt to adopt this resolution. On the roll call of yeas and nays, Alderman Varner, Toepfer, Endress, Boldt, O'Neill, Wright, Klemm, and Bender voted yea. The resolution was adopted.

RESOLUTION #R-2005-47

RESOLUTION TO APPROVE FINAL PLAT FOR COUNTRYSIDE ESTATES SUBDIVISION PLAT 13

WHEREAS, Section 5/11-15-1 of the Illinois Municipal Code (65 ILCS 5/11-15-1), authorizes a city to enact an ordinance mandating that the city council approve all plats of subdivisions to be located inside city's corporate boundaries or within a one-and-a-half mile area extending from said corporate boundaries provided that the city has also enacted a Subdivision ordinance; and

WHEREAS, the City of Freeport has enacted such a Subdivision Ordinance, known as Chapter 1224 of the Codified Ordinances of the City of Freeport; and

WHEREAS, Section 1224.05(d)(6) of Chapter 1224 of the Freeport Codified Ordinances provides that all Subdivision plats "shall be submitted to the City Council for approval and for acceptance of all streets, alleys, ways, easements, parks or other areas preserved for, or dedicated to, the public, by resolution"; and

WHEREAS, on June 20, 2005, this City Council approved the preliminary plat for Countryside Estates Subdivision, located within the city limits of the City of Freeport, Illinois; and

WHEREAS, the final plat for said Countryside Estates Subdivision Plat 13, a copy of which is attached hereto as "Exhibit A", and made a part hereof, substantially conforms to the preliminary plat as approved; and

WHEREAS, at a special meeting held July 28, 2005, and subsequent to a public hearing, the Freeport Planning Commission unanimously recommended that the City Council approve the final plat for Countryside Estates Subdivision Plat 13.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, ILLINOIS that the Final Plat of Countryside Estates Subdivision Plat 13 as set forth in Exhibit A, is hereby approved.

BE IT FURTHER RESOLVED that the City Clerk is hereby directed to attach a copy of this Resolution to a copy of the plat, for the purpose of recording the plat by the subdivider with the County Recorder; and upon said recording of the plat, the subdivider shall file a certified, reproducible copy of the plat with the Community Development Office.

BE IT FURTHER RESOLVED that this Resolution is expressly adopted pursuant to the Home Rule Powers of the City of Freeport under Section 6 of Article VII of the Illinois Constitution of 1970; and all Resolutions or parts of motions in conflict with this Resolution are repealed insofar as they conflict.

Alderman Varner, Chair, stated that the committee held a meeting on August 1, 2005. The committee voted unanimously to adopt this resolution and Alderman Varner so moved, seconded by Alderwoman Bender.
