#### RESOLUTION #R-2005-78

RESOLUTION TO AUTHORIZE AN AMENDMENT TO FIXED ASSET POLICIES AND PROCEDURES POLICY AND TO REPEAL ALL CONTRARY PROVISIONS OF SAID POLICY

**WHEREAS,** the Governmental Accounting Standards Board (GASB) requires fixed assets reporting in order to be in conformity with generally accepted accounting principles; and

WHEREAS, a Fixed Asset Polices and Procedures Policy was adopted by the City Council of the City of Freeport on May 2, 2005;

**WHEREAS**, said Resolution included the document attached hereto and made part hereof as Exhibit A as submitted to the Department of Justice for compliance of the regulations for federal grants.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, ILLINOIS that pursuant to the Department of Justice Exhibit A be amended to include the following:

11) Equipment Purchased with Federal Funds – Tangible personal property purchased with federal funds with a useful life of more than one year and an acquisition cost of \$5,000 or more shall be considered a fixed asset and as such shall be inventoried by the Finance Director or his or her designee.

The City shall adhere to all guidelines set forth in the Office of Management and Budget Circular A-102.

**BE IT FURTHER RESOLVED** if any section, clause or provision of this Resolution be declared by a Court of competent jurisdiction to be invalid, such decision shall not affect the validity of the Resolution as a whole or any part thereof, other than the part so declared to be invalid, and this City Council expressly declares that it would have enacted this Resolution even with the invalid portion deleted.

**BE IT FURTHER RESOLVED** that this Resolution shall be in full force and effect upon its passage by the City Council, its approval by the Mayor and its publication (if any) as required by law.

**BE IT FURTHER RESOLVED** that the provisions of this Resolution are severable, and if a court of competent jurisdiction should declare any portion of this Resolution to be either invalid or unenforceable, said decision shall not affect this Resolution as a whole or any part thereof, other than the part declared to be invalid or unenforceable.

**BE IT FURTHER RESOLVED** that all resolutions or parts of resolutions in conflict with this Resolution are repealed insofar as they conflict.

# **RESOLUTION AUTHORIZING SUBMITTAL OF UNITED STATES ENVIRONMENTAL PROTECTION AGENCY BROWNFIELD ASSESSMENT GRANT APPLICATION**
