- Insurance certificate** All contractors must submit a Certificate of Liability Insurance indicating a minimum general liability limit of at least \$1,000,000 per occurrence for bodily injury and property damage. The City of Freeport must be listed as the certificate holder.
- State licenses** Plumbers and roofers must submit proof of state licensure and expiration date of license.
- Fees** All contractors must submit the appropriate fee. See page 2 for fee amounts. Make checks payable to "City of Freeport."
- Certifications** Submit copies of any applicable certifications or other licenses, e.g. lead and asbestos certification.

### REQUIRED TESTING

Electrical and HVAC contractors must pass a local test and remain current on licensing. See page 2 for additional information.

#### REQUIREMENTS-GENERAL

- All contractors** No person shall engage in work within the City of Freeport as a contractor unless that person has first obtained a contractor's license from the City.
- Insurance** All contractors must submit a Certificate of Liability Insurance indicating a minimum general liability limit of at least \$1,000,000 per occurrence for bodily injury and property damage. The City of Freeport must be listed as the certificate holder.
- Complete Applications** Contractor's licenses will not be issued until all required documents, to include application form, fees, proof of licensing and testing, and insurance certificate have been received. It remains the responsibility of the applicant to submit these documents.

#### REQUIRMENTS FOR SPECIFIC TYPES OF CONTRACTORS

- Electrical contractors** No person shall perform electrical work as a contractor unless he or she is, or has in his or employ, a registered supervising electrician. Registered supervising electricians must pass an examination administered by the Building Commissioner. The exam covers all phases of electrical work found in the NEC. Electrician licenses may be renewed from year to year without the exam, provided that the annual application and all supporting documentation are submitted prior to January 1. Failure to submit a complete application before this deadline will result in the need to re-test.
- HVAC contractors** HVAC contractors must pass an examination administered by the Building Commissioner. HVAC licenses may be renewed from year to year without an exam, provided that the annual application and all supporting documentation are submitted prior to January 1. Failure to submit a complete application before this deadline will result in the need to re-test.
- Plumbing and roofing contractors** Plumbers and roofers must submit proof of up-to-date state licensing.
